In order to make this event mutually successful, we ask that you help us with the following requirements that are necessary for participation:

- 1) Each company may be represented by **no more than two (2) persons per table, or four (4) persons per booth. (Please provide the names of the staff represented at each table or booth).** Companies must have their table staffed at all times by at least one person from 11:00 AM-2:00 PM. Affiliates that do not purchase a table **will not be able to market themselves or their company.**
- 2) Each company may reserve as many tables as desired. There will be one (1) table assigned per registration fee. Table assignments will be handled on a first come, first served basis, in order of registration. (See attached for floor plan). Fees must accompany registration, confirmation will not be sent until payment is received.
- 3) Promotional materials relative to your company may be placed on this table. A limited number of tables are available with electrical outlets (first come, first served). Company must provide own electric cord. Any signs or other advertising material must be placed on the table. No floor or wall space may be used; any exceptions must be approved in advance. All tables are 8 feet long.
- 4) **SET UP TIME WILL BE 9:30 AM.** It is mandatory that you participate until the 2:00 PM closing, then dismantle.
- 5) The registration fee is \$170/members and \$220/non-members (non-refundable) per table. Electricity will be available for \$195/members, \$245/non-members. Display booths (10x10) will be available for \$270/members and \$320/non-members.
- 6) Refreshments will be available.
